# Passing on what was So Freely Been Given

aking on a Service position comes with the opportunity to build on work that has been done by our predecessors. We take the fruits of the Founders, the contributions of past contributors and the structure supported by GSO to carry the message in a more effective way. We benefit, the current fellowship and public at large benefits and, if we do our job well, future A.A.'s benefit. We can pass on the legacy of service much stronger than the day it was handed to us.

Where does this begin? Often the answer is "in the home group".

Among those A.A.'s you see weekly, you can contribute by acting as a greeter, making coffee, holding a position like Secretary or Treasurer. For me, it began with cleaning up after a meeting. That gave me a responsibility that drew me back each week and it kept me connected.

From the group we look to both the District and Intergroup. General Service Representatives (GSR's) and Intergroup Delegates connect the group to a larger geographic area. Each gives a group representation in a larger arena and acts as a conduit of information from A.A. as a whole back to the group. Districts help organize activities that bring A.A.'s across groups together in service. For example, they organize meetings at Jails and Treatment Facilities; hard for one group to do alone.

And there are a number of

Service Committees in Northern NJ. Look to www.nnjaa.org/ area44/commit.htm for complete descriptions and functions. Seven of these committees are jointly sponsored by Area 44 and Northern NJ Intergroup. These provide essential 12 step work. They have been built by our predecessors and provide opportunities to strengthen your sobriety and give back. Not only do they provide sobriety enhancing work but reach out to the community at large (including those still suffering). They provide a face for and information on A.A. to the wider world. Each committee position has a tradition of rotation. Chairs and Secretaries serve for two years and pass on their work to the next... the goal is always to leave a committee stronger than it was when you joined.

The Newsletter Committee carries the word in print. It reports A.A. activities in Northern NJ and carries articles of interest from Area and Intergroup Officers. Highlighted are pieces submitted by members at large. Then there

Let's not neglect the digital age. www.nnjaa.org was developed and is maintained by the Website Committee; a joint Area 44 and Intergroup effort to provide online access to events and meetings. The site introduces A.A. to the still suffering, provides a calendar of activities for current members and provides you with meeting locations and times.

And what about Northern NJ Intergroup and NNJGS Area 44? Intergroup pulls together information on roughly 1300 meetings publishing a meeting book and populating the website meeting finder. Northern NJ General Service Area 44 acts as a bridge between The General Service (GSO) office of A.A. in NYC and individual A.A. groups. The two have both unique and joint functions aimed at strengthening the fellowship, passing group concerns on and receiving collective wisdom.



y name is Matt, I am an Alcoholic. I have been around the program of AA for 20 plus years, my last drink was September 11, 2005. I try to give the experience I have received to others simply by doing the 12 Steps in my daily living.

I remember years ago when I first heard of Night Watch, I was attending a few meetings a week in Chester. I had found that meeting by calling Intergroup, I didn't have a computer at home much less have one on my phone back then either. Chester's Motto was and probably still is, "I am responsible. When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that: I am responsible." That seemed perfect to lead me into doing Night Watch whenever a shift was available, no matter if it was my Home Group or not. At that time just about all I knew of AA was how to get to a meeting, being around for a year or so myself. You can only give away what you have and that was my extent of experience, I did learn however to ask for help when something came up during a phone call if I didn't have an answer. I knew I could get one from my Sponsor or someone in my network. Being that connection to the newcomer or the new person in town was then, and is still today, an important part of my sobriety. If I could just help make it easier for someone to get into AA that was enough to keep me interested in doing it.

Over the years, as I progressed in my recovery, I progressed in Night Watch. I found myself becoming the Leader for the commitment even though it may not have been my Home Group that I was doing the commitment for. Then I became Night Watch Coordinator for Morris and Passaic Counties.

Now being on the Night Watch Committee as a Coordinator I get to help in many other ways it "lets me" become more involved with many other Groups that I don't get to frequently. I expand my network and I pass on the experience of letting a group pull together and do a commitment that has never done one in the past. I also try to give groups the same week or just about the same time they had one in prior years. I get to visit groups that I haven't seen in a while and work with some of my friends that

I have come to know over the years that Night Watch got me involved with. Even just explaining to a new group by going over the manual the Step by Step instructions brings back different scenarios that I have had myself over the years of being on the front lines for my group. Every time the feeling of being of service to someone, or just listening to "a live one" brings me back, but for the Grace of God there go I.

I don't know if I will ever be able to repay Night Watch for all that this commitment has done for me, because every time I do another commitment my Gratitude list grows..



lcoholics Anonymous in New Jersey is now 75 years young! It was both the best of times and yet the worst of times during the spring, summer and fall of 1939 as AA's fourth group, "The New Jersey Group," took shape in South Orange, N.J. On April 10, 1939, the fledgling fellowship had finally codified its program of action with the publication of Alcoholics Anonymous. The book boldly proclaimed, "We, of Alcoholics Anonymous, are more than one hundred men and woman who have recovered from a seemingly hopeless state of mind and body." Bill would later write of the pioneers: "Two-thirds were located in Akron... Most of the remainder were located in or near New York City..." Most of the "New York City" members were actually from New Jersey. These pioneering members of the New York contingent would gather at Bill's home at 182 Clinton Street in downtown Brooklyn and sign the first copy of the book which had just rolled off the Cornwall Press. This crowning glory would be short lived as dark clouds formed on the horizon.

On April 26, 1939, Bill and Lois were finally evicted from their home on Clinton Street. The moratorium on foreclosures imposed by the government during the latter half of the depression

had ended, and Bill and Lois lost the home that Lois's mother and father had given them. They put their furniture in storage and left for Hank and Kathleen P's home in Upper Montclair, New Jersey.

A few days later, Horace C., a New York pioneer, would come to the rescue and donate the use of his family's Green Pond, N.J. cabin for the month of May. Bill and Lois shuttled back and forth from Green Pond to the little office of Honor Dealers in Newark where Bill and Hank had written the book and were desperately trying to eke out a living selling automobile polish.

At this time there had been but two meetings of this young fellowship each week, a Tuesday evening meeting at Bill's Brooklyn home and an Oxford Group meeting on Wednesdays in Akron, Ohio where Dr. Bob and the Akron folks gathered at the home of T. Henry and Clarace W. On May 11 a third group formed and began meeting in Cleveland. They called these gatherings "meetings of Alcoholics Anonymous" and thus the fellowship had taken its name from the newly published book.

On a Sunday afternoon, May 14, 1939, the very first meeting of what was to become the New Jersey Group of Alcoholics Anonymous took place in the home of Hank and Kathleen in Upper Montclair. Meetings that had been formerly held in Brooklyn were held in New Jersey for the next five or six weeks. The meetings began at 4 p.m. and went most of the night. They rotated speakers for the first portion, according to Jimmy B. who

was living at Hank and Kathleen's home at that time. These were dinner meetings, with Herb D. of South Orange paying for a "big spread." The wives always attended these along with their spouses.



At the May 14, meeting they voted in the "Bill and Lois Home Replacement Fund" and each pledged different amounts of which none of them paid more than a few months. They wrote up a document with this information, which is housed in the GSO archives. (Bill and Lois were running an errand when they voted for this fund; they arrived shortly thereafter and Lois wrote in her diary that they were thrilled.)

Shortly after, Hank and Kathleen would spilt up. It was rumored that Hank wanted to leave Kathleen and marry Ruth Hock, the Honor Dealers secretary who would become Bill's right hand at the A.A. Foundation. Kathleen kicked the whole bunch out and the meetings moved to the Hartford Road home of Herb D. in South Orange. Bill

recalled these interesting times in a talk he gave before the Manhattan Group in 1955:

Well, it was then the spring of 1939. Temporarily, the Manhattan Group moved to Jersey. It hadn't got to Manhattan yet. A great friend, Horace C., let Lois and me have a camp belonging to himself and his mother, out at Green Pond. My partner in the book enterprise, old Hank P., now gone, lived at Upper Montclair.

We used to come down to 17 William Street, where we had the little office in which a good deal of the book was actually done. Sundays that summer, we'd come down to Hank's house, where we had meetings which old-timers — just a handful now in Jersey — can remember.

The New York members would return across the Hudson River in late June and meet at a host of different locations in Manhattan and Brooklyn until they secured the West 23rd Street Clubhouse in early 1940. At this time, the New Jersey Group was beginning to grow and claimed about 15 members. A.A. in New Jersey had officially begun.

In early September, Hank P. had returned to drinking. Bill's first sponsee, the great promoter of the Big Book and the founder of Alcoholics Anonymous in New Jersey would never again enjoy long-term sobriety. Hank nursed resentments against Bill for the rest of his life and caused division within the A.A. ranks in the months to come. Bill and Lois actually left New Jersey to avoid having to give testimony in the divorce action that Kathleen had brought against Hank. At the end of the summer

of 1939, Bill and Lois moved in with Bob and Mag V. Their farmhouse, named Bog Hollow, was located near Monsey, N.Y. Bob was a member of the New Jersey Group with just six months

sobriety at the time. On October 22, 1939 the first-ever public meeting of Alcoholics Anonymous in New Jersey was held at the South Orange Community Center. A newcomer with just five months of sobriety, Gordon M. of East Orange, along with Herb D. of South Orange, had arranged the public meeting space to accommodate the growing fellowship.

The "Jersey Group" now had 25 to 30 members attending on Sunday evening at 5:30 p.m. and marking the start of regular Sunday night meetings held at the Community Center. It was this group that would become the "Mother Group" for all of New Jersey. Later this group would also be familiarly known as the South Orange Sunday Night Group, and its meeting time changed to 7:15 p.m., which it still is today.

On January 1, 1940, the group produced a membership roster that is housed in the GSO archives. The survey was conducted in preparation for the Rockefeller

dinner in February. The member list shows 41 names, but indicates seven are no longer group members. Of the active members, there are several pioneers of A.A. and five people with between one and three years of continuous sobriety. Another 19 members have between three months and one year and six are working on 90 days. The group

claims an overall success rate of 73% with 46% getting and staying sober on the first try.

The membership of the New

The membership of the New Jersey Group represented more than twenty-three towns including, South Orange, East Orange, Orange, West Orange, Bogota, Jersey City, Caldwell, Newark, Montclair, Upper Montclair, Irvington, Glen Ridge, Bloomfield, Westwood, Millburn, Verona, Plainfield, Ridgewood, Hoboken, Hackettstown and Roselle and two upstate New York towns.

Three of the newcomers with less than one year, Ray W., Gordon M., and Helen P. would become active in group affairs and later appeared in one of the photographs in the Jack Alexander article of the Saturday Evening Post, March 1, 1941. Ray helped start A.A. in San Francisco and both Gordon and Helen would hold trusted servant positions in the early years of the group. Lois's diary indicates that she and Bill attended the South

Orange meeting on February 18, 1940 and then spent the night at Gordon's East Orange home.

As the membership in New Jersey grew many changes occurred. The New Jersey Group actually became a legal business entity with its incorporation in 1941. It was then legally know as A.A of New Jersey, Inc. This is of course prior to the traditions being written and the incorporation of the New Jersey Group was done to allow it to conduct real estate transactions, purchase property, sign leases and contracts, etc. — activities somewhat incompatible with today's A.A. Traditions

In 1941, the Jersey Group began to give birth to its children. The second group in northern New Jersey was the Morristown Group started by Dr. Malcolm T. Morristown was followed by groups in Englewood and Fairlawn. The South Orange group also began holding a Tuesday luncheon meeting at the Howard Johnson's in East Orange. The New Jersey Group held an anniversary dinner on March 14, 1942 at the Hotel Suburban, 141 South Harrison Street in East Orange. The featured speaker was none other than Bill W., and the cost was \$2.50.

By 1943, there were burgeoning groups in Newark, Bloomfield, and Montclair, and in 1944 the Newark/Roseville group in association with dozens of A.A. members from local groups formed a corporation called the Alanon Association and purchased a building owned by the Roseville Athletic Association (Roseville A.A.) There was no need to change the name on the building!

Growing A.A. in New Jersey led to the formation of New Jersey Intergroup which had its first offices at the Alanon Club. The Intergroup Committee of A.A. of New Jersey, Inc. became official at a meeting held in May 1945 when the Articles of Association were adopted by the delegates representing 16 A.A. groups in New Jersey.

So, from its very humble beginnings, A.A. in New Jersey has grown today to more than 1,100 groups with over 1,800 meetings per week. This November, the South Orange Group will celebrate its 75th anniversary throughout the weekend of November 28-30 at in South Orange. Hopefully, all of New Jersey A.A. can show its gratitude and join in the celebration of New Jersey's "Mother Group," A.A.'s fourth group!

"Holy Smokes!"

was blessed to have been given the gift of desperation which lead me to the rooms of AA 15 years ago. I put down the bottle, but it took me four years later to put down the cigarettes. I realized, as I was driving to work one day and planning out how, when, and where I would smoke during the work day, that cigarettes had become my "master," as did alcohol. I wanted to be happy, joyous, and free- and I was not free when my addictive behaviors transferred from alcohol to cigarettes. I stopped smoking a few years before NJ went smoke free in 2006- and I had to change my meetings because at that point most of the meetings I attended were smoking meetings. I was grateful when the laws changed in NJ, so that I could feel free to attend any meeting- smoke free. But I did have sympathy for my smoking-friends-I know exactly how that nicotine craving feels at that certain time of the day!

But what does all this have to do with drinking? Not much. But it has a lot to do with AA. I have a medical condition that makes my skin very sensitive to many chemicals. I have spent lots of time, money, and pain dealing with this condition that- frankly- existed when I was drinking but when I was drinking I was numb to EVERYthing! So when these new "e-cigarettes" came out I was concerned because I couldn't imagine that they really do contain "only water vapors." I started noticing more and more, particularly over the past two years, people smoking e-cigarettes indoors- and so I looked into what they actually contain. I found out that though e-cigarettes contain significantly








less second-hand smoke toxicity than regular cigarettes, they do still contain chemicals that are carcinogenic and the effects of which have not yet been determined to be safe by the FDA. There are a ton of different studies out there which claim, from both sides of the issue, to support or disprove the second-hand effects of e-cigarettes. I am not trying here to argue the pros and cons of this issue- but I am here simply to use this forum as an opportunity to share with you all that regardless of the debate, the fact of the matter is that one of the chemicals that I am most allergic to is found in the vapor of all e-ciga-

I thought that this was my issue alone- and that when people were smoking e-cigarettes in meetings, that I just had to leave and find a different meeting. It's been hap-pening more and more often, and when I've asked people to not smoke, I haven't been given such spiritual responses back. I recently found out though that in 2010, the NJ Smoke-Free Air Act of 2006 was amended to include a ban of smoking e-cigarettes in indoor

public places. I urge you all to look it up yourselves and educate your homegroups to discuss this issue and consider putting a line in your announcements that smoking- including e-cigarettes- is not allowed in the meeting. I have been told that this is an outside issue- and I get that. I don't know how else to make people aware of this. But I know that we have the best Area and great AA's and I hope that you will take my article to heart. My medical condition is not life-threat-ening- it's painful and annoying, but I've been dealing with it all my life. But what about our fellow AA's who are struggling with other medical conditions where their immune systems are compromised, or those AA's who have to bring their children or infants to meetings? I'm sure if you all knew more about this issue then more people would be considering the fact that when people are smoking e-cigarettes in meetings they are not only breaking the law, they are compromising the health of those around them.

using as a Fall 2013 novice to the AA. Do I really belong here? The leaders say the only requirement to be in the program is a burning desire to drink. Well, that IS how I felt. But Al-Anon is where it all began for me in 1985.

I was off the wall and he was drinking. AL-Anon said don't talk to them when they are drinking, and that alcoholism is a disease. Finally, I STOPPED Racing all over searching for a way to stop my husband from destroying himself, our marriage and our family. Al-Anon told me that I could not stop another human being from drinking. To this day I believe this is still true. Yet, now I know that only Almighty God can help anyone who either asks Him to, or is being prayed for by others, for the deliverance from this sin, or any other addictive sin the accuser of the brethren chooses to fling his tormenting arrows towards.

Fast forward to This Day August 14, 2014, by the grace of God I did not buy that bottle of Blackberry Brandy, which my father would often give me a sip of as a child, when I did not feel well, or that romantic bottle of wine that would lull me into a delicious state of calm and reverie that would dance me into Frank Sinatra's ballads enfolded into the arms of the man who I had fallen in love with when I was fourteen years old, my children's father. NO, I NEEDED TO GO TO

AA, like I needed to breathe and I did. I breathed and went to AA.

What catapulted me into this place, this burning desire to drink, were several uncontrollable events snowballing around me all at once. I felt as if I was caught up in an avalanche. A friendly real estate agent, who I met in Walgreens in the fall of 2013, brought to my attention that my children's father had moved from the home we had raised our children in, where he was living with his current wife since 1996. Our towns bordered each other. It never occurred to me that there was a sense of security I must have felt, living in such close proximity to him. We did not have an ongoing relationship, as he had remarried. My mindset had been established in AL-Anon and it remained ongoing. Don't talk to the person when they are drinking. A teaching to this day I regret having believed, for I have become aware that the Holy Spirit can reach anyone at any time, for He uses anyone open to His leading. My reaction baffled me for I have lived, by the grace of God, through incest, divorce and two cancer diagnoses without wanting to drink. Although I did ask my physician for a prescription for medical marijuana, which he promptly refused, but then suggested for me to buy it on the street. That was shocking to hear from a man of such pristine values, but he knew the pain I was experiencing. Oh, I forgot to mention that the

year before the divorce, which was 1988, I was drinking and smoking, but not eating. Eventually I realized by God's divine intervention that I was killing myself so I stopped.

Having been blessed to be in the AA rooms since the fall of 2013, I no longer feel out of control with the sinful thoughts of drinking, smoking or having sex. Having learned about the importance of having a relationship with Jesus Christ in the Al-Anon rooms years ago, today I also have a relationship with Jesus' Father whom I

have come to know as Abba Father. Upon inviting Jesus into my heart in 1985 the Holy Spirit came to dwell there also, in my heart that is One Day At A Time, This Day.

My heartfelt prayer is that all who come in these rooms of AA will find the fullness of faith that the God who created all of us wants to impart into our lives. May all who seek HIM find HIM FOR he loves us all.
