

The Nightwatch: A "Call" to Service

not only sufficient but preferable to a phone call. Why take even one minute to make a call when the communication can be made instantaneously without having to speak to another person? Yet, when we really need someone else's help, such as an emergency situation or when we need guidance, directions, or when we just need to vent, we still use the phone.

For decades, Alcoholics Anonymous (AA) has provided hotline numbers throughout the country where those that want release from the bondage of alcohol can find help. The Northern New Jersey chapter of AA operates a 24-hour, 7 days a week hotline that can be called any time, day or night, by an alcoholic in need: (908) 687-8566.

Pursuant to Tradition 8, our chapter has a fantastic team of employees, who operate our service center during the day and whose duties encompass answering the hotline during business hours. They are always there for an alcoholic in need, but we alcoholics are a desperate sort that often require assistance into the wee hours of the night, on the weekends, and even during holidays (well, especially during holidays). During these off-peak hours, we could just turn the hotline over to a service center or let the answering machine get it. But we know that there are hopeless people out there searching for our way of life who will never find it if a fellow alcoholic is not there to welcome this newcomer to the program.

Enter Nightwatch. We are a group of fellow alcoholics that volunteer to operate the Northern New Jersey AA hotline on Saturdays, Sundays, holidays, and from the hours of 6 pm to 8 am on Monday, Tuesday, Wednesday, Thursday, and Friday.

During a typical shift, most calls we take are just an individual looking to find a nearby meeting or to chat for a couple of minutes with an empathetic alcoholic who can relate to their story. Many of these calls are from people with a "couple of 24s under their belt," and might incidentally teach you, the volunteer, a thing or two about "staying stopped." But we also occasionally get a call from a person that is desperate. When such a person calls, we act as a pseudo-greeter telling this prospect about our better path of life and hoping to find them someone from our 12-Step network that can further introduce them to the Steps.

The Big Book, our Steps, and our Traditions make clear that our primary purpose is to help the next alcoholic in need, and, as recovering alcoholics, we have the rare privilege of getting to pass this true

freedom to another.


really happened and what's it's like now.

Should we develop a pamphlet on the unhoused alcoholic in A.A.?

BACKGROUND

Area 40, Montana, has proposed an agenda item to develop a pamphlet on AA and the Unhoused Person that specifically addresses alcoholism, what AA is and is not, and includes personal stories from AA members who have experienced homelessness. This agenda item was brought to the Area 40 assembly and passed with substantial unanimity.

By developing this pamphlet, Area 40 believes that it addresses a growing population with relatively high rates of alcoholism, reaches out the hand of AA to an underserved remote community, creates a resource for professionals working with this population, creates a tool for sponsorship for those working with unhoused individuals, and creates a space for formerly unhoused AA members to share their experience, strength, and hope.

While many pamphlets have targeted specific groups—for example, newcomers, Black and African American, Hispanic Women, LGBTQ and Young People —there is no pamphlet specifically written for the unhoused alcoholic. The only thing close to this type of pamphlet was from a 1957 recommendation which stated "Consideration be given to the possibility of developing material for a pamphlet to include case histories for the skid row alcoholic, a pamphlet that might be available in jails." In 1958 at the GSC, it was expressed that "There is no need for a pamphlet to include case histories for the skid row alcoholic, which would be available in jails, at this time."

In some of the background data provided by Area 40, "Homelessness is a broad term to describe someone who doesn't have a permanent residence. While homelessness is often associated with living on the street, that is not always the case.

Homeless individuals may live in an emergency shelter, transitional housing, or a car. Alternatively, they may bounce around from place to place, staying with people they know. By definition, anyone who does not have 'a regular, adequate, and stable night-time residence' can be considered homeless. According to the National Alliance to End Homelessness, in 2020, more than 500,000 people in the U.S. were considered homeless on a nightly basis.

Some additional facts and statistics about homeless people and addiction:

- Approximately 38% of all homeless people abuse alcohol
- Close to two-thirds of homeless veterans suffer from alcohol or drug abuse

Demographics most affected by homelessness and alcohol abuse are veterans, teenagers/young adults, women, and LGBTQ community."

The hope is if this recommendation is approved a pamphlet will be developed for Alcoholics Anonymous and the Unhoused. This pamphlet can be used in both inward and outward facing capacities. Members from the AA Fellowship will have the opportunity to share their experience, strength, and hope with being homeless or unhoused as content for the pamphlet.

PROS

- The pamphlet will allow people from the unhoused population to see themselves in and on the front of some of our literature and know that they have a place in AA.
- Professionals will also be able to use this pamphlet as a resource specifically for the unhoused and homeless.
- The pamphlet could help the homeless with any barriers to sobriety.

CONS

- There are enough pamphlets already targeting the demographics that are cited in the recommendation.
- With GSO looking to cut costs, is it the right time to develop a new pamphlet along with the printing costs that will occur?

What does your home group think?

TOPIC II - CORRECTIONS*

(Final Conference Agenda Items III-D)

*This Literature item was added to the Corrections Committee agenda per the Equitable Distribution of Workload (EDW) plan

Should we develop a pamphlet on the transgender alcoholic in AA?

BACKGROUND

Alcoholics Anonymous has always tried to fulfill its responsibility to reach all alcoholics who need us. As stated in the Preface to the Fourth Edition, "All changes made over the years in the Big Book have

had the same purpose: to represent the current membership more accurately and thereby to reach more alcoholics." This agenda item is in keeping with the spirit of this Big Book statement—should we produce a new pamphlet specifically geared for the transgender alcoholic.

Some recent history.

In 2015, at the 65th General Service Conference, the Conference Literature Committee recommended that "The trustees' Literature Committee update the pamphlet "A.A. and the Gay/Lesbian Alcoholic" to include a wider range of AA recovery experience from members who are gay, lesbian, bisexual, transgendered and gender nonconforming..." Approved by the full Conference as an Advisory Action, a call for stories was sent to the Fellowship. With an expressed need and response so overwhelming, in 2018, the pamphlet "Experience, Strength and Hope: LGBTQ Alcoholics in A.A." (P-32) was published and distributed to our Fellowship.

Should we develop a pamphlet on the transgender alcoholic in AA?

The proposed agenda item (PAI) states, "Gender identity is different from sexuality, and the unique barriers of transgender, non-binary, genderqueer, gender-fluid, and gender non-conforming could be better addressed in a separate pamphlet." In other words, being transgender is different than being gay or lesbian.

- In 2018, the Queer Femmes group from Oakland, California and their local District passed this motion with substantial unanimity.
- They were advised to wait for the forthcoming LGBTQ pamphlet to be published before moving this forward. After reviewing this new LGBTQ pamphlet, district members believed there still was a need for a separate pamphlet.
- In 2019, the motion was presented at California Northern Coastal Area of Pre-Conference Assembly. "A.A. has already acknowledged and registered this material need, and begun to address it. The recent pamphlet 'Experience, Strength and Hope: LGBTQ Alcoholics in A.A.' contains moving and inspiring stories from trans alcoholics in recovery." Nevertheless, they felt a separate pamphlet necessary, citing unique and particular barriers that trans people face when trying to access recovery.
- This issue was then discussed at four separate assemblies over two years. In April 2021, the motion passed with substantial unanimity (166-5), and the Delegate submitted a PAI—the Trustees Literature committee reviewed but took no action.
- The proposal was submitted again in 2022 with the same result.
- During a 2023 Assembly, Area of again discussed the need for this pamphlet and voted with substantial unanimity to submit a PAI—and it was added to the 74th GSC agenda.

A closer look at the pamphlet, LGBTQ Alcoholics in A.A.

"Thirteen LGBTQ alcoholics chronicle their experience before and after joining Alcoholics Anonymous...stories by recovering alcoholics who self-identify as lesbian, gay, bisexual, trans and transitioning, and queer". Three of the 13 stories are from transgender alcoholics who found sobriety in AA.

From Sammy (page 19) "When I first came to Alcoholics Anonymous, I knew I was transgender...I never felt like I belonged in the LGBTQ community, and for the longest time I wasn't sure I belonged in AA..."

We need to consider whether the three stories from transgender alcoholics contained in this pamphlet are adequate.

A growing community.

The Area of 2019 presentation cites 1.5 million trans people in the U.S. alone with extremely high rates

of alcohol addiction—and this community is proportionately underrepresented among our Fellowship. Recent studies are supportive:

- 2022: UCLA Williams Institute—more than 1.6 million people in U.S. identify as transgender
- 2022: Pew Research Center—5% of young adults in the U.S. say their gender is different from their assigned sex at birth
- 2021: Journal of American Medicine—transgender people had more than three times the alcohol abuse than cisgender adults

Conclusion

In final comments, Area of emphasized that they were resubmitting this item because the need for the pamphlet continues, stressing sexual orientation and gender identity are not the same thing. Their multi-year discussion at the Area level resulted in an informed conscience concluding that "an ever-growing and strongly expressed need warrants the creation of a separate pamphlet. Pamphlets are inexpensive to produce, serve as invitations to welcome new and potential members, and help educate their sponsors and others."

PROS

- This is a growing community of people with unique issues that can benefit from a separate pamphlet.
- While the LGBTQ pamphlet includes stories from transgender alcoholics, it doesn't go far enough to address the needs of trans alcoholic members and potential members.
- The transgender population continues to grow, has an extremely high rate of alcoholism, and is underrepresented in AA—a dedicated pamphlet may help trans alcoholics believe AA is for them too.
- Yes, we need it, gender identity is different than sexual orientation and should be treated as such.

CONS

- The LGBTQ pamphlet was just produced in 2018; let's devote our resources elsewhere.
- There are already three stories from transgender AA members in our current pamphlet.
- We already have too many pamphlets in AA.

What does your home group think?

TOPIC III - GRAPEVINE/LA VIÑA

(Final Conference Agenda Item V-C)

Is it effective or sustainable to continue printing La Viña?

BACKGROUND

In 1995, based on an expressed need, the General Service Conference passed an Advisory Action to print a bi-monthly Spanish edition of the Grapevine. This was done on a 5-year experimental basis to determine whether such an endeavor was feasible. In 1999 and 2000, the Grapevine Conference committee stated the following:

"Being mindful of the demonstrated effectiveness of La Viña and the strong support expressed by the Hispanic community and considering its spiritual benefits as a Twelfth Step tool, the committee wishes to express strong support for its continued publication."

Due to the "strong support" and "spiritual benefits," the Conference voted in 2001 to have the AA Grapevine Inc. publish La Viña bi-monthly and to provide support for this magazine as a service to the Fellowship. This permanently established La Viña but provided a different mechanism for its funding. The Grapevine is funded through subscriptions and the sale of other items like books while La Viña is funded as a service with an objective of being self-supporting but with no mandate to do so. In 2012, the format of La Viña was changed to bring it into spiritual parity with the Grapevine with La Viña being perfectly bound (with the staple removed so that they could be brought into prisons), with 68-pages in black-and-white. In 2018, color was introduced to once again be on par with the Grapevine. In 2020, the Conference recognized the importance of spiritual parity between the Grapevine and La Viña and renamed the Conference Grapevine Committee to the Grapevine & La Viña Conference Committee. Over the past 12 years, there have been several additional considerations from the Grapevine Conference Committee to stress the importance of La Viña attempting to be self-supporting even though it is a service and concern over the funding of La Viña as a service to the Fellowship.

The questions that this agenda item seeks to answer are: is there still strong support for La Viña from the Hispanic community and do the spiritual benefits of publishing La Viña bi-monthly outweigh the cost to the Fellowship.

The Potential Agenda Item (PAI) is from a member and focuses on the financial aspects of publishing La Viña. This individual does not recommend that we discontinue publishing La Viña but suggests that it would be prudent in light of concerns over the Fellowship's finances to have the discussion of whether the Fellowship can continue to sustain the losses from publishing La Viña.

The background material also includes the financial information from the past 6 years of publishing La Viña. This information is interesting and enlightening and shows the effect that the Pandemic has had on the finances of La Viña. Prior to the Pandemic, La Viña was produced at a loss of between \$150,00 and \$250,000 which represents roughly between 1% and 1.5% of the overall AA budget. Due to the Pandemic, subscriptions fell by 37% and expenses skyrocketed leading to fairly large deficits of over \$636,000 in 2022 and nearly \$750,000 for 2023. The 2024 budgeted amount predict a significant drop in the deficit to about \$570,000, a reduction in costs and a 22% increase in subscriptions.

PROS

In his Foreword to the Service Manual on page 1, Bill W. writes:

Concerning any given service, we therefore pose but one question: "Is this service really needed?" If it is, then maintain it we must, or fail in our mission to those who need and seek AA.

With regard to the spiritual nature of La Viña and the support from the Hispanic community nothing has changed. Therefore, as Bill states, maintain La Viña we must!

As far as the financials are concerned, a quarter of a million dollars is a large deficit especially at a time when the Fellowship is receiving letters from our General Manager and the General Service Board talking about monetary issues and a large overall deficit. However, this is exactly what our reserve fund is for. During the Pandemic, we had two rather larger drawdowns from the reserve fund to deal with lower contributions and a loss of revenue from literature sales. The Fellowship has responded and has been contributing in record amounts. In addition, if the budget forecasts for La Viña are accurate, then the financial situation of La Viña will be greatly improved this year and, hopefully, as we move further away from the Pandemic, the situation will continue to improve.

Regardless, keeping in mind what Bill W. said, about a service, it would seem that the spiritual nature and the experience, strength and hope shared on the pages of La Viña would outweigh the financial considerations.

CONS

The deficits for publishing La Viña over the past two years were quite significant. As opposed to pre-Pandemic times, a deficit of \$750,000 represents almost 4% of the overall AA Service budget. This comes at a time when AA as a whole is struggling financially as we have seen based on the letter from our General Manager and messages from the General Service Board from their talks at service assemblies and regional forums. While the 2024 budget projects that the financial situation for La Viña will improve, budgets have been known to be wrong. One can wonder whether the budget projections are accurate and sustainable. At this time, the Fellowship will not be able to ascertain the accuracy of these projections and if they are wrong, could lead to further drawdowns and erosion of our Reserve Fund.

While our Fellowship is a spiritual one, we have a business to run as described in Concept VI. The General Service Board has a fiduciary responsibility to the Fellowship to make decisions for the good of the Fellowship. Sometimes, these decisions like discontinuing publishing La Viña are difficult but necessary to make. Should La Viña cease publishing the General Service Board and the AA Grapevine would have to find more cost effective ways to provide the stories of Spanish alcoholics to the Fellowship.

TOPIC IV - GRAPEVINE/LA VIÑA

(Final Conference Agenda Item V-E)

Should we develop a pamphlet on the Asian and Asian-American alcoholic in A.A.?

BACKGROUND

The Trustee's Literature Committee considered a request to develop a pamphlet for Asian and Asian-American alcoholics with stories of experience, strength and hope and agreed to forward to the 74th General Service Conference.

The Proposed Agenda Item (PAI) comes from Area 49 (Southeastern New York, SENY). The topic was discussed at their Area Assembly in 2023. It was seconded, there was a discussion, and then a vote. The Area supported this proposed agenda item with substantial unanimity (two-thirds vote) by a vote of 90 in favor of supporting with 2 opposed and no abstentions. The proposed agenda item is fully supported by an Area with substantial unanimity.

An Area 49 committee member who is an Asian in recovery wrote that the drinking culture is different for many Asian members in comparison to Western culture. Culturally, Asians don't believe that drinking alcohol is a problem; they have a mindset of having a sense of control. Their culture centers around the ideology of honor and shame. When one experiences a problem with drinking, it brings cultural shame to their family, and they are then shamed within their own society. Furthermore, he explains that during the COVID-19 Pandemic, some Asian-Americans experienced verbal and physical abuse on the streets, which deterred many from returning to AA and seeking help. It was also stated

that the Chinese translated Big Book only contains the first 164 pages of the Big Book of Alcoholics Anonymous, and there are no personal stories in the back. There is historically no record of any Asian representation in any of our Conference-approved literature nor the personal stories in any edition of the Big Book.

We have one primary purpose and that is to stay sober and help other alcoholics to achieve sobriety. When that newcomer walks in the door, most of us know what to do. We greet them, hand them a cup of coffee, help them to a seat, and the magic begins to unfold once the conversation begins and we share our experience, strength, and hope. But, how well are we reaching the alcoholic that hasn't found their way to the door yet? The alcoholic who still suffers doesn't even know we are here yet. Is there more work that can be done to perhaps further and deepen our reach?

According to the 2022 Membership Survey conducted by the General Service Office, the Composition of Membership of Alcoholics Anonymous reveals that the majority of our membership are predominantly white members at 87.7%. The less represented populations include Asian at 1.2% (6% of the US population is Asian according to census.gov) and Pacific Islander or Hawaiian Native at 0.3%.

Currently, The General Service Conference has approved many pamphlets that help people identify their alcoholism and seek assistance in culturally relevant fashion. Pamphlets have been developed for members of the armed forces, those with mental health issues, older alcoholics, those with accessibility issues, persons in custody, LGBTQ+ alcoholics, teens, young people and women. In addition, the Conference has approved pamphlets directed towards those with spiritual concerns.

At this time, only three Conference-approved pamphlets deal with issues of race and ethnicity: AA for the Black and African American Alcoholic, Hispanic Women in AA, and AA for the Native North American. Omitted from this list is any pamphlet for Asian and Asian-American or Pacific Islander Alcoholics, the population with the least representation and composition of our membership. Pamphlets are often used as tools for committees such as Cooperation with the Professional Community (CPC) and Public Information (PI). This can be a useful asset not only to current and future Asian and Asian-American members to relate and identify, but also to bring awareness of Alcoholics Anonymous and to reach any organizations, hospitals, institutions and programs that focus on this population.

PROS

- This can help Asian and Asian-American alcoholics with the power of identification showing that others that come from similar backgrounds are able to get and stay sober in AA.
- Pamphlets are a useful tool to be given to treatment programs and medical organizations that focus on this population.
- Other pamphlets have already been created to help reach other alcoholics that are the least represented of our membership.
- Currently, there is no representation of Asian and Asian-Americans in any of our literature, including the personal stories in the Big Book. This pamphlet would historically be the first piece of literature to help reach this group.

CONS

- We already have many varieties of literature. Do we need to splinter ourselves more with special interests when the basic tenets of Alcoholics Anonymous caters to everyone?
- A pamphlet may not be the most effective tool to reach the Asian and Asian-American population. There may be better solutions to this problem, such as developing another form of literature or utilizing our digital and website assets.

• Can our resources be better allocated elsewhere to help carry out 12-Step work that would be more applicable to everyone.

TOPIC V - INTERNATIONAL CONVENTIONS/REGIONAL FORUMS

(Final Conference Agenda Item XIII-D)

A. Consider options for closing the Big Meeting at the International Convention

BACKGROUND

Over the years, there has been some concern by members that the use of the Lord's Prayer conflicts with our program's traditions, etc. that we are not allied with any sect, denomination, etc. in that the Prayer is viewed by many as a Christian prayer. One of the earliest addresses on the issue was a response Bill W. wrote to a concerned member in April 1959 defining the prayer's origins for being used in our meetings and wide spread use confirming "since this is the general consensus it seems only right that at least the Serenity Prayer and the Lord's Prayer be used in connection with our meetings." Accordingly, it's wide use has continued over the years.

However, many members have also continued to question its use. In fact an agenda item regarding its use at the International Convention has been on the Conference agenda for the past few years, which culminated in a survey of the Fellowship on the issue being requested by the 2021 Conference Committee. The results were reviewed by the International Conventions and Regional Forums Trustee Committee prior to the 2023 Conference. The Trustee's Committee found that the results (summarized below) "did not reflect an overwhelming desire by the respondents to change the current practice (i.e., the chairs of the Big Meetings at the International Conventions have been invited to close with the Lord's Prayer, some closing with the Serenity Prayer and some closing with the Responsibility Statement."

When the Conference Committee on International Conventions and Regional Forums reviewed the report in Committee at the Conference in 2023, they determined in part "the consensus of the Committee was that we should keep with the current practice of closing the Big Meetings at the International Convention wherein the chair has the choice of closing the meeting with either the Lord's Prayer, the Serenity Prayer or the Responsibility Statement." Accordingly, no motion was brought to the Conference floor.

However, a floor action was brought forward stating, "The options for closing the Big Book Meeting at the International Convention be the Serenity Prayer or the Responsibility Statement." Because the Conference ran out of time for substantive discussion on the floor action, a motion passed to recommit this item to the Trustees' Committee on International Conventions/Regional Forums. Hence the Trustees Committee has now returned the item for consideration to the Conference Committee.

PROS

- For several coventions, the chairs of all 200+ meetings at the Convention have been invited to close in the manner of their choice, which has been The Lord's Prayer, the Serenity Prayer, or a Moment of Silence. No major issues have occurred.
- As noted in the survey's, there is no strong response to change the current practice.
- Leaving the choice up to the leader leaves it in the hands of the membership.
- Since we have AA members from different (or no) religious backgrounds, sticking to the common prayers (Serenity Prayer, Third Step Prayer and Seventh Step prayer) would be more inclusive.
- Removing the choice of the Lord's Prayer would signal to the newcomer that we are not a religious program but rather a spiritual one.
- It is an International Convention; AA is open to all. The Lord's Prayer may be foreign or offensive to the International Attendees.

CONS

- Removing the choice of the Lord's Prayer would depart from one of our largest and most treasured customs.
- To many, it will signal a diminished importance of a higher power in our program.
- Keeping the Lord's Prayer in, the survey indicates that the wishes of half of our membership will be met. However, Bill has said decisions should be made by substantial unanimity to maintain unity.
- Since only 50% of the respondents want to keep the process unchanged, inclusion of the prayer will continue to be a large issue.
- Removing the prayer from the Convention could impact group meetings and raise more controversay.

Meet Some of Us!



This new column was inspired by the statement in "A Vision for You" that states "you will surely meet some of us as you trudge the road of Happy Destiny." It will feature conversations with various AA members about some of their experiences and thoughts. It's another way to get to know folks in our Fellowship a little better.

Conversation with Rocco S by Atul D

There were a few things that finally made Rocco make the decision on 8/6/2022 to do something seriously about his drinking. There was a night—like others before it—where he started drinking with the intention of controlling his drinking. As the evening went on, he lost control of his drinking once again, and it ended up in the same place — blackout. He tried to control it for many years with the same result again and again and again. This time he also thought about the fact that his behavior might mean he would never see his wife and daughter again. Rocco realized that his efforts to moderate or stop on his own were not working.

During the first three to six months of recovery, the focus was just on staying sober—keeping it the number one priority. He kept telling himself that. His head was spinning with all kinds of thoughts, anxiety, fears. However, going to 90 meetings in 90 days helped a lot. He made it a point to be active in meetings. Going up to people, introducing himself, offering to help with meeting-related tasks kept him busy. Rocco soon got to know people and started to feel comfortable. He would make sure to ask people how they were doing and reach out and say hello to newcomers. On days he could not make in-person meetings, he made it a point to go to a virtual meeting. After 90 days, he signed up to lead meetings, go on speaking commitments and stay connected. Looking back, he thinks the emphasis on connecting with other alcoholics and staying in regular touch was a big help.

He feels his sobriety is strongly dependent on a few actions and attitudes he continues to emphasize and recommends these to newcomers. First, Rocco gave up trying to get sober his way. He was open to suggestions from those who had been successful in recovery, especially old timers. Second, he focused on the fact that alcoholism is a disease. This helps Rocco with not trying to deal with his alochoism on his own, and he suggests others try it as well. Finally, he tried and built a bridge with a Higher Power as best as possible. He builds a relationship with his Higher Power by starting the day with a prayer, asking for the strength to stay sober. At night, he says thank you to his Higher Power for helping keep him sober that day. It is a start to a connection with a Higher Power.

There are definite ways Rocco feels his life has improved in sobriety. First, he is no longer looking over his shoulder, worried about what past behavior might catch up with him. Second, there is a definite joy in knowing that he is doing the right thing most of the time. This gives him serenity and peace of mind. Finally, he feels that he is now able to live in the present and enjoy it—not worry about the past or fear the future. He is very grateful for his sobriety!

Experience, Strength and Hope and Prejudice

Good morning. I haven't had a drink since 1985, and I'm grateful to Alcoholics Anonymous and my Higher Power for making that happen.

I came to AA because I had tried stopping drinking, and I couldn't stay stopped. (Spoiler alert: I had kept thinking.) I was 29 ½ years old. I look back and see my Higher Power walking me gently into AA. She gave me the inspiration, information (find the phone number in the front of the phone book, and they will tell you where to find the next beginner meeting), and mysterious power so few people understand that I needed in order to develop the willingness to accept the AA way of life.

This morning I was looking for a topic for this article and found my current favorite there in our book *As Bill Sees It*, (formerly *The AA Way of Life*). Entry 328, "A New-Found Providence" talks about the support that I needed from AA when I came in: not arousing prejudice about spiritual terms. They told me to read the Big Book, so I read the whole thing. It aroused in me antipathy, because the language was both spiritual and Christian. I was not Christian, although I was definitely spiritual in my approach to the Spirit of the Universe. I had a strong relationship with my Higher Power and didn't want to be talked to in Christian terms. At the time, I was one of the many people who want to rewrite the Big Book to suit their point of view.

Luckily, I lived in a town where there was at least one AA meeting every day. So, I started my journey in AA: I made 90 meetings in 90 days.

Entry 328 quotes the Big Book, page 93: "There is no use arousing any prejudice he may have against certain theological terms and conceptions... Don't raise such issues no matter what your own convictions are." Religion is an outside issue, as discussed in our Tradition 10 "Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy."

The 12 & 12, pages 176-177, states: "So long as we don't argue these matters privately, it's a cinch we never shall publicly. We do not enter into public controversy because we know that our Society will perish if it does." These parts of AA made me feel welcome at a time of social upheaval. And when isn't there a time of social upheaval?

I don't have to rewrite the Big Book anymore. It's a treasure described in the foreword to the first edition.

I live and love AA because it saves lives. It saved my life when I didn't know that I was in danger of dying from alcoholism. My doctor had told me that if I drank while taking the psychiatric medicines she had prescribed, I could have a heart attack. I kept thinking, so it took two more months for me to stay stopped. It took outside help for me to get to the rooms of AA. It took the Fellowship to get me to read AA literature. It took some crazy group chairman telling me (and 50 other attendees at my sponsor's

meeting home group) every week, "I love you, I love you, I love you."

I'm grateful to my Higher Power for guiding me gently to AA, and I'm grateful to AA for accepting my Higher Power. Thank you for letting me share. I pass.

My Skewed Perspective Asking for What I Need: A Study in Self-Absorption

As sobriety rolls along, I am starting to dig deeper into my causes and conditions. One of the items that has popped up for me is that there is too much of "me" in many situations. Asking for what I need is one of those.



I must let go of the notion that I cannot ask for what I need, because I create problems with my jealousy and comparing instead of just stating what is going on with me. That hesitation is internal; it does not come from anyone else. "I'm not worthy or important," I tell myself, but is it about wanting to be the center of attention? I hide in the corner, hoping to be noticed and singled out. I am creating a problem – or at least most of it – based on my ego, fear, and self-worth issues. My perception is off.

I need to let go of what others think of me (there's the "me" again) and ask for what I need. It's so simple, and yet I complicate it. When I don't let go, I often create problems that don't exist, especially when it comes to jealousy and comparisons. I need to stop worrying about proving myself, especially now that I am semi-retired, and focus on what I am doing.

That means staying in today. I have been receiving that message from several different sources lately. I have fears and problems with reality – at least partially – because my mind is often elsewhere, and not where my feet are. When I do that, I am like the actor in the Big Book who wants to be the director: writing scenarios, deciding how people should act, worrying about what will happen. The world according to Marybeth. My mind starts chattering, so OF COURSE I have trouble with reality. I focus on my discontent, which leads to hurt feelings, embarrassment, and self-centeredness.

Selfishness, self-centeredness. That's what I see and can recognize today. I can ask my Higher Power to remove them because I cannot on my own. And then I need to let go. After that, I will be free to ask for what I need, and my Higher Power will be with me.

Opening the meeting, the leader in a Louisiana Cajun accent chair asked for volunteers to read "What is AA" and "The Twelve Steps." When the chair asked who was visiting from out of town, a show of hands from San Francisco, Florida and, of course, New Jersey were raised. As newcomers to the meeting, my friend and I received a pink welcome chip. It read "Pass it On" on one side and "Pink Cloud" on the other.

I carried my chip in my wallet until my home group meeting in Bridgewater, NJ. We break up into two meetings: regular meeting in the front room and beginner's meeting in the rear room. That night, I joined the beginner's meeting and met an AA who was returning after a time "out there." After the meeting, I passed on the pink cloud chip and never gave it another thought.

Many months later, our group had a speaking commitment in Hunterdon. With a group of well-wishers after the meeting, a clear-eyed, happy young man identified himself to us. You see, I never saw that gentleman again after his first time at our Bridgewater meeting and didn't remember him. The young man held in his hand, you guessed it, the pink cloud chip. He was excited. It turned out HE couldn't remember where HE got it but was passing it on the next day to someone leaving the Freedom House! When he heard me speak that night, he connected the dots.

I hope that chip has a long, happy journey through our fellowship.

We still go back to New Orleans. A few weeks ago, we were there again. We raised our hands and identified ourselves as visiting. The leader said with a smile "no, this is your home away from home!" The beautiful part is that we felt it before he said it!

Or maybe, he does he not exist at all, except


In the hearts of humans
