I will share that report with the Committee and the Area when I receive it after the Conference. I was also asked to do a presentation at the Remote Communities meeting describing the excellent work that our committee has been doing.

Most of all, I was feeling grateful and humbled to have been given such an amazing opportunity.

How We Use the Big Book in Our Recoveries

For me, the Big Book is like a recipe that outlines precisely and exactly how to recover from this fatal disease of alcoholism. I use the book like a textbook that we would use in school. Or in my case, what I probably should have done in school... Today, I mark it up and use a highlighter on certain terms, phrases and words. I write definitions of words and circle words such as must or vital to remind me as I read how important these words are.

Several years ago, I was at a crossroads in my journey. I found a new sponsor and was honored that she gave freely of her time and took me through the Big Book in a way I had never experienced. That process changed my life. I would go to her home on a regular basis and before we opened the book, we prayed on each occasion and asked God to

help us set aside our old ideas and open our minds to a new experience. We proceeded to read the pages together. She shared her experience with me just as her sponsor had done with her.

Today, having had a spiritual awakening, I make myself available to do the same with women who are looking for a new experience, taking them through the book just as my sponsor did for me.

The Assembly will be coming up on June 8th at which time we're going to have a town hall discussion and presenters speaking on the topic of "Inclusivity of our African-American members." What I find amazing is that according to our 2014 membership survey, white people make up 89% of AA Membership and Black People make up only 4%. The big question is why there is such disparity. What are we not doing in our fellowship to attract the black community to Alcoholics Anonymous? Are we, as recovered alcoholics, falling short in our 12-step work as described in the chapter Working with Others? What has your group done lately to bring the AA message to the attention of professionals in the community—the physicians, clergy, court officials, educators and others who are often the first to see alcoholics in need of help? If we review Chapter 7, Working

with Others, we see that it provides instructions for us on how to find people to help. It reminds us that we can help where no one else can. We can find people by asking doctors, ministers, priests or hospitals. When was the last time we approached a minister or priest to connect us with someone who may have a problem with drinking? Our founders used this approach all the time.

I'm hoping to hear a lively and inspiring discussion touching on all these questions and hearing our fellowship share their ideas and thoughts on what more we can do.

A sober example of how our program of recovery and service will work for you, and a reason why you might be just desperate enough to want what we have to offer.

The principle and purpose on which Nightwatch began and continues, is to be there when someone calls looking for help when the Intergroup office is closed. Our Nightwatch groups and volunteers make that possible 7 days a week, 52 weeks a year. We are grateful to the groups that have made Nightwatch an annual group service commitment and to the many AA members, both long time and first time volunteers, who step up to answer the call each and every day. Nightwatch is not an easy or convenient commitment. But there is a wealth of experience and support behind each and every shift; from the Intergroup office, through the local Nightwatch coordinator and group leaders, to each volunteer and 12th Step contact. Together we have pointed countless numbers of AA's to their first or next meeting, provided empathy and resource information to concerned family and friends, and endured obnoxious and obscene callers at all hours of the day and night. Through it all we continue to learn the extent, as well as the limits, of our human ability to be of service to the suffering alcoholic, and the truth of the saying that we only carry the message so that God can deliver it.

This month the Nightwatch committee started a much-needed discussion on how best to attract and encourage interested AA's to participate in the work of the committee. We have a dedicated group of area coordinators who work directly with their local groups to manage the weekly Nightwatch commitments, but it would be great to have more AA's involved with the support work needed to move Nightwatch along even further. One project on the radar is to form a working group to review and update the Guidelines and Procedures and Step by Step sections of the Nightwatch manual. The committee is also interested in exploring best practices and more efficient ways to support our Nightwatch volunteers and 12th Step contacts as they cover their shifts and refer and return calls.

The committee is always in need of new perspectives and fresh ideas on how to be more effective in carrying the message of hope to the sick alcoholic, as well as to those whose concern is critical

Service in Action

I was about six weeks into sobriety when I attended the 2009 District 4/6 Day of Sharing. The speaker shared about an open meeting at the General Service Office (GSO) on Fridays. Since it was open to anyone and I was interested, I drove in and that was my first awakening.

I arrived at 475 Riverside Dr. and at the security desk I was given a pass which said, "VISITOR To 475". As I got into the elevator, I was asked, "Are you going up?" "Yes," I said, "11 please."

The elevator door opened, and I walked to the glass door. As I entered the lobby of the AA General

Service Office, I was greeted by an empty reception desk. After a few "hellos", a woman poked out from an office doorway, apologized and said, "The computers are down; we're trying to get orders ready to be shipped." She pointed to the archives room and said, "There are self-guided tour pamphlets; please help yourself".

It was there my journey began; it feels like it was just yesterday. Over the course of the next five years I got to know Luke H., a good sober man who was very involved in service events. When he said that District 4/6 needed a History & Archives (H&A) Chair, my first thought was, "I can't do that". However, I had agreed to go to the next district meeting, so I decided to take the position.

It has been almost 10 years since that first GSO experience, and I have been involved in service ever since. First, I became Daytime Coordinator and then GSR for my home group in Ho-Ho-Kus. Our group meets five days a week with three meetings at noon and three meetings at 6:00 pm, except Friday night, which is an open speaker meeting.

In 2015, I attended the Atlanta AA World Convention, and at that convention I served in the Area 44 Hospitality Suite where we displayed our H&A treasures. I was involved in the H&A presentations, including "Northern NJ Landmarks in the History of Alcoholics Anonymous" at our 2017 Area 44 Convention; and "Early AA -The Women" at our 2018 Area Convention and District 4/6 Day of Sharing. This year at NERD in early April, members of the H&A Committee provided a four-hour bus tour of some of New Jersey's historic AA landmarks. It was my privilege and honor to be one of the guides. So far, this has been my journey. More will be revealed.

On the inside cover of my first Big Book, I placed the "VISITOR To 475" sticker. Every time I open the book, I see it. A few years ago, without much thought, I decided

Clarity and gifts come in many directions. Churches would donate space for the rehearsals. The 'actors' would come from the rooms – twenty of them. And so it began.

The day before the convention, we took the newly formed play to a long-term residential rehab and presented back-to-back performances. The clients were weeping afterwards, not in despair but from gratitude. The same reaction occurred the next day at the convention.

Twenty-seven wonderful years have passed since then and the play that depicted the bottoms, the "spiritual awakening," and coming into the rooms would reach more than 40,000 people in the hearts of shelters, treatment centers, prisons, and communities.

The members of the play's troupe do not get paid, nor do they reveal their last names. In addition, the troupe declines media coverage. Today we have grown to more than 500 anonymous volunteers, many joining us from our audiences, carrying a message of hope and recovery to their peers. And with no funding we have made our way to eight states and as far west as Texas.

There are many gifts in recovery. Perhaps the most precious to me is the opportunity to carry the message of hope to my brothers and sisters.

MY SERVICE: OBLIGATION OR RESPONSIBILITY?

I have 25 years of continuous sobriety in Alcoholics Anonymous, and during that time I have performed several functions within my home group such as coffee maker and secretary, and I am always careful to carry the message to the alcoholic who still suffers in my role as R.S.G. (GSR). I was on the translation committee and in this capacity had the opportunity to attend functions in Area 44, to which my group belongs as part of District 30. This district is bilingual; therefore, I translated as needed.

For the year 2017 in a plenary meeting (full district meeting), the R.S.G.s named me M.C.D. (DCM) of the district, which I accepted with great enthusiasm although I was aware of some problems within the district. I took on the responsibility as an active member of my group and my district. Of course, I had to familiarize myself with the Service Manual, but I believed that my recovery sponsor would be able to double as my service sponsor. I discovered, however, that that was not the case. It was vital for me to look for a service sponsor in Area 44 - the right person with whom I could discuss my doubts and projects - and attend workshops on the Service Manual. I got involved on the Public Information Committee, and we participated in different activities that the Area hosts. We attended the international meeting that is held on Fridays at the O.S.G. (GSO), and I motivated groups that did not have R.S.G.'s to elect one and send that person. I maintained communication between the district and the Area and the Area delegate, and my service extended until 2018.

Today I feel happy with myself because during this period some very difficult life events occurred, but thanks to GOD and the program of AA I was always able to overcome them. Today I can say THANK YOU to my fellow group members, R.S.G.'s, and my sponsor for their understanding. And from the bottom of my Heart I want to give thanks to a Higher Power that I understand to be God, and for that I am responsible...

Don't Shut the Door on It

It's the last Friday of the month. Instead of reading a selection from the Grapevine magazine, we are reading and discussing the Promises. I don't need to reference the sheet the leader has distributed. The Promise pertaining to the month of February is tattooed on my brain: We will not regret the past, nor wish to shut the door on it. Early on, it was all about regret. Just walking in the door carried with it so much shame, guilt and remorse that I wore those feelings like a scarlet letter. Convinced that my badge of shame would follow me for the rest of my life, I went through the motions while saying the Lord's Prayer. How could God forgive me if I couldn't forgive myself?

When my beloved Grandmother died in December 1989, I was so distraught that I drank enough to jump into the grave as her casket was lowered into the ground. Elderly mourners reached in, supporting me as I clumsily steadied myself. My mother's words are engraved in my heart. "It's my mother we're burying, not yours." Continuing through tears, she whispered, "Once again, you're making a spectacle of yourself. Why, on this solemn day, are you making this about you?"

When my dearest friend arranged for state-funded respite care so that she could have a quiet night away from her severely disabled daughter, I was determined to help her forget her troubles. Ordering two shots of tequila, I pushed one towards her. "C'mon, have one." "No, thanks," she insisted. "I only have an hour." "Just one," I urged. "You can have just one." The more she refused, the more I drank. I recall the hurt in her eyes. Her daughter wasn't well. Her time was limited. She'd just wanted a night out with her friend. But all that mattered to me was getting her drunk.

My mother, my dear friend, my employer, my boyfriend, my landlord, a myriad of co-workers, members of my family...whom hadn't I hurt? The subtle judgments from those I didn't know personally, but seemed to know me, stung too: the clerk at the liquor store who rolled his eyes whenever he saw me struggling for pocket change; the teller at the bank who thought I was laundering money; the cop who stopped me going the wrong way around a rotary and questioned whether or not I had been drinking. I was regularly impulsive, unreliable and deceitful. How many times did I behave inexcusably? Let me count the ways.

Like the Jaywalker in our literature, I had a knack for doing the same bad thing over and over again while expecting different results. I could never find myself in the middle, in that sacred place I now know as right sized. Did I really expect to be treated with the same kindness and compassion with which one would treat a sick friend? Nearing my bottom, I was isolated, lonely and depressed.

It took me years to take an honest look at my behavior while drinking. Fortunately, I stayed close to my sponsor and eventually became willing to make the most of my formal amends. The living amends I now make to my friends and family allow me to put my head on my pillow at night and rest much easier than I ever did when I was drinking. There's abundant freedom in that.

Regret does dissipate, but not immediately. Like the way the Promises come to us "sometimes quickly, sometimes slowly," I still struggle from time to time when I am reminded of my actions while drinking. And while I'd like to believe that after 25+ years in recovery I am now a woman of honor and dignity, I would be lying if I didn't acknowledge that from time to time, I still behave regrettably. The difference is that I understand the value of looking at my part in interpersonal disturbances and make a concerted effort to promptly admit when I'm wrong.

For me, the beauty of not shutting the door on my past is that a window opens to help another alcoholic. Each of the experiences I've had while drinking has served in one way or another to strengthen my recovery. My resolve to do life differently as a sober woman strengthens when I share my story with another alcoholic. When I honestly admit that while drinking, I regularly behaved in a manner that was an embarrassment to myself and others, it gives a fellow alcoholic the opportunity to let go of similar burdens. We've all had a bumpy road to recovery. Allowing ourselves to look back without regret is a tremendous gift.

Someone said recently that for her the Promises were like cash and prizes – the kind you get if you work hard enough. If we are painstaking about this phase of our development, we will be amazed before we are halfway through. I was all for amazement. Having something to look forward to certainly piqued my interest in learning more. For some, knowing there is something tangible and positive dangling out there is a reason to keep coming.

Mom, the Big Book, and Me

The first copy of the Big Book that I saw belonged to my mother. I found it in her library after she died in November 1997. I was still drinking then. Mom had joined AA in 1977, although I wasn't aware of that fact until quite a while later.

When my drinking became significantly worse in 1979, Mom tried unsuccessfully to 12th Step me, but I wasn't ready. A few months following her attempt to help me, I nearly died in a drunk driving accident. I was in the hospital for a week, and when she failed to visit me, I erroneously assumed it was because she didn't love me. Later, I learned the truth: she was trying to detach from her alcoholic son.

As I browsed through her Big Book in 1997 (it was the 1976 edition), I paid attention to the passages that she had underlined, and that gave me valuable insight into her thoughts and feelings. I reflected on my relationship with her.

Mom taught me several lessons in sober living during her 20 years in AA. She showed me how to practice the AA principles in all our affairs. She also demonstrated the value of trying to help another alcoholic even if we never see our efforts succeed. I wasn't aware of these lessons at the time she imparted them.

In 1997, she was informed by her doctors that she had cancer, and the prognosis was very poor. Despite such horrible news, Mom was able to maintain her sobriety and her dignity. She didn't use the cancer as an excuse for drinking. As I mentioned earlier, I didn't come to AA until three months following her death, and thus I had no idea in the Fall of 1997 about any of the 12 Steps or the AA principles. All I knew at the time was that Mom was facing the ultimate crisis with a serenity and strength of character that I didn't know she possessed. I don't know if I could do what Mom did if I were to face the same situation, but I take some comfort in the idea that she probably didn't know before she got sick that she had the ability to be so courageous. Three months after her passing, I hit bottom. I woke up one Sunday morning with a terrible hangover, after having promised myself the night before that I wouldn't get drunk. At 10 a.m. on that Sunday,



I called the Intergroup Hotline, and someone answered (thanks, Nightwatch) and I asked for help. Two days later, I was picked up by a 12th Step Contact Volunteer and brought to my first AA meeting at The Loft, then located in Highlands.

For the first months, I made lots of mistakes - I went on drinking, I compared instead of identifying, and I thought I was different. But I kept going to meetings. Finally, I had that moment of clarity. It was March 14, 1998 and I haven't had a drink since.

After I got sober and learned about the 12 Steps, I considered Step 9 and was curious as to why Mom had not made amends to me - at least, I thought that she had not made amends to me. Eventually, I was told about indirect (or living) amends, and it seemed to me that Mom's sponsor likely had suggested that she make living amends to me. In other words, she should change the way she acted toward me. Similarly, my sponsor suggested that I make living amends to my wife when I reached Step 9.

Although Mom didn't live to see me get sober, I believe (and this is just my belief) that wherever her spirit is now, she knows that I'm sober, and she's happy.

My Big Book

I use the book Alcoholics Anonymous in my recovery several times a week. My hard copy is taped together with colorful duct tape and dogeared, filled with handwritten notes and captured insights accumulated over the years. I bring my Big Book to my weekly home group meetings, both of which are Big Book meetings. Tucked in the back of my book is a Big Book dictionary to help me understand the context of the terminology. In my purse I carry a small soft cover copy of the Big Book, which is helpful when spontaneously attending Big Book meetings, referencing something I hear on a recovery podcast, or traveling far from home. I can't say that any one section is a favorite, but the 9th step promises have always been a beacon of hope for me. I often read pages 83-88, to remind me how one lives a life in recovery.

I am grateful today that the solution outlined in Alcoholics Anonymous is available to me to help others. The "Forward to the First Edition" tells us that what is written in the book is 'precisely how' they recovered, so I use it as a 'text book' when taking sponsees through the steps, emphasizing that this book was written in hindsight – after they recovered.

When my Big Book is closed, I see the words Easy Does It written in indelible ink, reminding me of the people who first gave it to me at a meeting on Long Island. It was in 2013 at the end of my very first meeting when they handed me a hard copy, firmly responding to each question I asked by saying, "The answers are in the book." As a newcomer, I was puzzled that a book written in 1939 could help me and became intrigued as I read about the allergy in The Doctor's Opinion and recognized myself when I read about the 'real alcoholic' on page 21. The stories in the back of the book help me with identification - I do what they did, I feel how they felt, and I think the same thoughts. I am grateful when I read the warnings, prayers and promises throughout the book, as they continue to be relevant to me today.

ference reports!






