A message from your Intergroup Chair



bout 17 years ago, I became involved in service for the first time. I was the alternate GSR for my home group. I thought it was boring and a waste of my time. I was glad when it was over and I avoided any kind of service for the next eight years. For the last nine years I've been continuously involved in service. Has my opinion changed? If someone asks, my response is, "It's the same thing over and over again, but once or twice a year there's always some kind of controversy."

Controversy jazzes things up. Maybe this article will be controversial. Nah, that will not happen. I thought my article on Intergroup's finances was going to put me in hot water. It didn't. In a past article, I asked people to come up to me and say "Hi." No one did! Another article, my proof reader added that

we were looking for volunteers. I was worried at first, but then I figured no one would volunteer. No one did, at least not that I've heard about. Maybe a seed was planted. I can dream can't I?

Where there's an open microphone, you quickly learn who always has something to say. At the Joint Day of Sharing, someone asked me, "I'm not asking if you agreed with what I said but I'm wondering if you understood what I was talking about?". I said, "Yes, but if I cannot get my friends to agree with what I'm saying. How can I expect others to agree with me." A few days later he came up to me and asked how I knew his friends wouldn't agree? I chuckled and said I wasn't talking about him, I was talking about me.

Being the Intergroup Chairperson, I hear many concerns from A.A. members and A.A. groups. With help, all these concerns are addressed. These concerns have become a great asset to my sobriety. I am forced to spend hours re-reading our service manual, A.A. pamphlets and our traditions. I

talk to experienced members and I call GSO. We must never take anything for granted. I know the answers are out there. We just need to find the best course of action. That is the best course of action for A.A., of course.

Explaining what we find is a volatile situation. I don't know if I always do this but I know I cannot express any negativity. Most situations blow out of control even when I'm at my nicest. I've learned in sobriety that there is nothing wrong with saying something is wrong, disagreeing with someone or venting my anger. My character defects start when I expect others to agree with me or I expect to get my way. Of course I would be disappointed, but that's O.K.

With so many people in service, I am not alone. I try my best and that's a reward all by itself. I may make mistakes along the way, but I see them for the mistakes they are and try to learn from them. I think for myself and I question the people I follow. We don't have to agree, to be friends. I would rather

have a friend who challenges me, than have a friend who always agrees with me. The point is that the more opinions on the table, the richer AA can be. I am honored to be part of that.

With twenty one years of sobriety, is it still possible to grow? When you realize the gift of sobriety is the present. The past is a joy and the future becomes a dream of a happy and purposeful life. There for let us live but "One Day at a Time."


Working Together
Writing my last article as
your Area 44 Treasurer
is harder than I thought
it would be. I cannot thank you
enough for this wonderful opportunity to serve you and AA as a whole.
I have learned a lot of things, but the
main lesson is that Area 44's commitment to carrying the message to

the still sick and suffering rocks!

About a year ago, the fellowship expressed their concerns over the area budget and expenses. Since then a new balanced budget process has been presented for 2013, expenses have been cut and the fellowship took responsibility for their 7th Tradition and increased contributions. Seeing the service structure work to solve a problem is amazing. From the Finance Committee through the ACM to the districts, the facts were presented and the groups took control. Look at the comparison chart showing where we

were in September 2011 vs. September 2012. We have gone from a \$20,000+ deficit (under guideline) to a \$7,000+ surplus (over guideline). That is the direct result of us working together, and I am completely blown away!

I would be happy to turn the reigns over to Wayne G. (your new Treasurer) and the rest of the incoming panel and say, "Here you go. Everything is set. You are in good shape." While we are in good shape today, we still need to be aware of what's going on around us and what we know is coming. Mother Nature has been flexing her muscles to interrupt and even close meetings after losing their space. We have been selling record amounts of literature, and those profits have been paying for the literature going out through the committees. What happens when the fellowship switches over to e-books purchased directly through GSO? We have to keep the message of the 7th Tradition out there and continue to work together to keep our primary purpose of carrying that message in mind. It saved my life and I am responsible to make sure the hand of AA is out there for others reaching out for help.

# Standing 'O' for "TIPPLER"

Play written by Jeff W. and Sharon G.

he Grapevine Committee presentation of Tippler on the Roof, an alcoholic instructive adaptation of the slightly more famous Fiddler original musical and movie, was performed at the Area 44 Conference at the Double Tree Hotel in Somerset. NJ on Friday night, September 21 and again on Saturday afternoon. This critic attended the Saturday performance which was standing room only. Listening to the music (Sound Coordinator: Wayne G) introducing the first scene, the audience waited with excitement and bated breath for the opening of the curtain and the entrance of Grapevine Thespian Players.

The story takes place in the Ukrainian ghetto village of Anatevka in 1905 where Tevye (played by Jeff W), a tavern owner who's severe alcoholic behavior is based on his theory that when you drink spirits, one gets spiritual and performing this "religious" experience on top of the roof of the tavern is nirvana. Being a leader of men and head of his household, he has convinced his wife Golde (Sharon G) and their daughters Tequila (Jeff B in drag - brilliant costume and makeup - you couldn't tell), Schnappsi (Lori Mc), Brandy (Suzanne M), Rumica (Laura H) and Ginny (Gabby G) that being spiritual, the liquid sort, is a way of life. However, at this point in the play, all seem to be systematically destroying themselves.

While the play addresses a very serious family addiction problem, the audience is held captivated with interwoven humor and song as well as drama. Some of the songs from the original Fiddler are adapted to fit the script such as the song 'Matchmaker, Matchmaker' as performed by Golde: 'Bartender, Bartender Make me a drink Buy me a beer, Act like my shrink...

Enters Yente (Sandi W), who is the town Matchmaker... and a drunk. She brings news that Lazar Wolf (Roy S), the butcher, wants to marry Tequila the oldest and most beautiful daughter (Jeff B in drag - very funny). But alas, it is not to be. Tequila loves Shmendrik (Mike K), the Tailor, and he wins over Tevye, the father, because of his intense love for Tequila and tequila. A wedding soon follows with much merriment and more songs: "Brownouts, Blackouts..." performed to the melody "Sunrise, Sunset...". As the party continues, drinking turns into the expected excess drunkenness, wet and dry heaves

Alas! A moment of clarity. Schnappsi (the ugly duckling of the sisters played by Lori Mc, herself a beauty in real life, made unattractive through the miracle of Hollywood makeup) comes walking in with a cup of coffee and announces that she is giving up drinking after realizing that she is an alcoholic. Even though the scene takes place over a hundred years ago, Schnappsi pulls out a Smart Phone (I think it had a hand crank on it... for that period look) to go to the AAGRAPEVINE.ORG site to find out more about AA. She then sings a rendition of "Leaving the Booze I Love" from the Fiddler tune "Far From the Home I Love." It is a lilting but stinging love song as she bids a permanent goodbye to her longtime and passionate lover, John Barleycorn. NARRATOR (Mike M): "Schnappsi jumped right into the steps. She felt a new freedom and a new happiness."

At this point in the play, this writer could not keep up with the rapid activities going on the stage. Nine months or so pass. Schmedndrik and Tequila, the newlyweds, reappear and Tequila (Jeff B in drag - very funny) goes into labor and delivers a baby... a baby with a beard... on stage. A very humorous

Everybody seemed to be positively affected by the redemption of Schnappsi while living the life of sobriety and the AA way. After Tevye falls off of the roof in the process of having another "spiritual" experience, Golde persuades him to examine his life and have a real connection with God. He then goes through a 10 verse rendition of "If I Joined the Program" performed to the tune of "If I Were a Rich Man." It seems the whole cast makes a covenant to quite alcohol at this point and join the AA program with the aid of the GRAPEVINE monthly publication or the hand cranked electronic version. An AA meeting is held on stage. Enters

Perchik (Freddie H) with a Cheshire cat smile and announces that he is the GRAPEVINE Rep and has an affection for Schnappsi. He explains to everyone that The GRAPEVINE is "...our meeting in print." The group then breaks out in an AA version of "Traditions."

The show concludes with a happy ending with everybody sober, working the steps and reading their monthly subscriptions of GRAPE-VINE. Tevye and Golde convert their tavern to a coffee shop wondering who would ever spend "...3, 4, 5 bucks on a cup of coffee?" The finale brings everybody in the troupe together to sing with much gusto: "Subscribe! Subscribe! To GRAPE-VINE." Placards are brought out and the audience joins in. The song and merriment builds to a crescendo and a "Standing 'O' for TIPPLER ON THE ROOF." Two thumbs up!

The cast achieved their goal of demonstrating to the audience how the GRAPEVINE can be a very positive part of living the AA life. As Perchik said it is "our meeting in print." ### Area Committee on Corrections

he level of commitment of the Area 44 Corrections Committee is indeed inspiring. I say this as chair of a nationally recognized committee prominent in the recovery of alcoholism. Our committee is made up of 25 core members who are key components in facilitating vital 12th step work in the correctional facilities of Northern New Jersey. It is not out of the ordinary to have over 40 people at our meeting on a sunny Saturday morning at the area office. The meetings consist of AA members who share experience, strength, and hope about how and why we make this work

happen. All of the county jails (except one) in Area 44 have AA meetings brought inside and are in contact with our committee. The committee's purpose is to support local 12 step work and educate our fellowship about the work. The AA literature brought into facilities (in Area 44) is picked up at the regular Corrections Committee meeting on the third Saturday of the odd numbered months.(fourth Saturday in January.) This literature is funded by spare change collected in "pink cans" at many groups and meetings. In 2011 the pink can contributions were over \$10,000. All this money was used to bring AA literature to incarcerated AAs. We bring meetings into many halfway houses and lock down facilities as well. Some facilities currently do not have AA meetings for one reason or another

but we have contacts who bring AA literature inside. The "pink can" idea started about 30 years ago in California and was adopted and approved by our area after that. Our work would be greatly handicapped if the "pink can" money did not exist. All groups that contribute to the "pink can" are thanked in This Day (see below).

Any AA is welcome to join our committee. The sobriety time of our members ranges from less then a year up to 30 years. Everyone does what they can when they can. One of our members is responsible for booking over 1000 meetings per year brought into lockdown facilities. Others focus on their local county jail or state prison. We have members who have started meetings in prisons after years of being shut out. Many participate in corrections

correspondence; writing to incarcerated AAs in prisons across the country. The Corrections Committee is flourishing because of the hard work and dedication of our members and everyone who has participated in this work in area 44. I have spoken to other correction chairs whose committees are struggling with only 4 members. We should be proud and realize how lucky we are in Northern New Jersey. Invite us to speak at your home group or district event. Come to our next meeting on January 26. Everyone is welcome and plenty of service opportunities are available that do not require anything more then a desire to serve.

# Founders' Day Celebration, June 8 - June 10, 2012

t was the week before Founders' Day and my husband asked if I started to pack my bags yet. Of course I had not. I am of the persuasion that I do best the closer to the deadline I get. If I think too much I may talk myself out of doing the thing I really want to do such as a LONG drive to Akron, Ohio.

We drove out of New Jersey on the morning of June 6, 2012 and arrived to our hotel in Akron that evening. We checked in to our room, walked around the area of the hotel to find some food, and then settled in for the night. My husband and I planned to arrive early and head up to Cleveland on Thursday to experience the Rock and Roll Hall of Fame. It is all it claims to be and a great preparation for our weekend with our fellows in AA.

Being there now, and remembering back to the summer of 1984, this day was in stark contrast. I remember back then wondering where the glory days went. Today I know the glory days are NOW as a sober recovering member of AA. I suddenly realized again how God is doing for me what I could never do for myself.

Friday we drove to Dr. Bob's house but it was locked up. People were milling around in preparation for the tour buses to come by on Saturday carrying

This is Dr. Bob's recollection of his initial conversation with Bill W:

"Now, as he finished his story with these wry attempts at humor, watching to see if Bill 'understood,' something began to dawn on Dr. Bob S. Slowly, at first, then with sudden clarity, he understood. Bill Wilson had been able to control his drinking problem by the very means— the Oxford Group— that Bob himself had been trying to use...but there was a difference. 'The spiritual approach was as useless as any other if you soaked it up like a sponge and kept it to yourself.' The purpose of life wasn't to 'get,' it was to 'give': for all his dabbling in religion and philosophy, Dr. Bob had never before realized that simple and now obvious fact."

hundreds of sober recovering people who came to celebrate our phenomenal fellowship. It is written on page 164 of the Big Book that our founders will be with us in the "Fellowship of the Spirit." How blessed are we who are part of this great movement of people who have found purpose and meaning in life. "That feeling of uselessness and self-pity [has] disappeared" (page 82). I began to experience an immense feeling of gratitude for my life, for God, and for AA. I fell in love with this program all over again.

We drove into the University of Akron parking deck and disembarked to join in the festivities of the weekend. We attended an early 12 Step Panel to get started and then moved on to the AA Early Bird Meeting. One of the speakers of the day found AA by way of the roars of the motorcycles that were assembling for the procession to Dr. Bob's grave side. That eventful Sunday morning he was awakening out of a drunken stupor and he asked his father what all that noise was; he was promptly directed to AA. He was



19 at that time, but on this day he was speaking from the podium as a 21-year-old miracle of this program.

Friday night we attended the Old Timers Panel and after that we were entertained by the Serenity Singers. It was a very full day for us followed by one more meeting of the night. Saturday also proved to be a very full day of meetings, a trip to Dr. Bob's house that included an outdoor backyard barbecue. We then went back to the campus for food and rest. The day ended with a huge meeting of 10,000 recovering people which took place in

the football stadium. The last time my husband and I attended Founders' Day was more than 10 years ago. The big meeting then was held in the basketball court which would only accommodate a fraction of 2012's attendees.

On this trip to Akron we did not attend the memorial service at Dr. Bob's grave site but the memory of the last time we did still touches me and fills me with emotion. I rode my own motorcycle that year in the procession to the grave site. Our journey back to New Jersey was peaceful. We listened to one of the CDs that we bought and chatted about how much we both love AA, how much AA has given to us, and how it is our responsibility to always be of service in the rooms that have given us both so much. As the Big

Thinking like this comes easy to most, but I learned to think this way in AA.

Back home I am really involved in AA Service, and I know how much work goes into the smaller AA events. Days Of Sharing, Picnics, Alkathons, etc; they all take hard work. But this Convention is a massive undertaking, and takes a lot of volunteers. Hours and hours of hard work and self-sacrifice, yet still everything is perfect. No one in AA has to tell me what the volunteers get from their hard work and self-sacrifice. Service work at this level of AA, is usually the result of gratitude for the program. The results from the hard work are usually always spiritual. Hard work for others, with no compensation, translates into spirituality.

I am soaking up the feeling of AA down here. The feel of AA back home is just not the same. Earlier in the week I was trying to explain to a sponsee,

what it was like down here. I told him that first of all, people at the convention are very happy. They are also people that are very involved in AA service. Maybe I'm a little crazy, but do you think there might be some sort of connection there? I don't want to be accused of jumping to conclusions, or something even worse, of taking other member's inventory, but you can't hide the facts. So let's just say that the people down here have more items in their toolbox, to take a good inventory of. It is no surprise that the six or so people down here from our District, do the majority of the AA service work in our area. This probably holds true for most people at the Convention. These are the people who make AA work. Everybody else in AA gets to reap the benefit of the work they do. Action and service in AA, leads to greater humility, the humility to spirituality, the spirituality to increased serenity.

Like-minded people will always gravitate to each other. Just like problem drinkers hang out with people who drink just like they do. Or best case scenario, people who drink worse than them. This pattern seems the same at the

Convention. Service oriented people go to the Convention. They gravitate to where the service people are. Their opposites in AA, mostly hang out at our beloved discussion meetings. Conventioneers love The Traditions, they live in the Steps, and do service work. Sounds

like those Three Legacies in action!

When I got home today from the Convention, I felt somewhat rejuvenated. Being around like-minded people does that. Hearing your thoughts and ideas about program being reinforced by others, is a welcome change. Then reality hit hard, a sponsee asked me if I was going to our Sunday night discussion meeting. This was a tougher question to answer than normally. Did I want to risk losing some of this Convention feeling? Going from the Convention, directly to a discussion meeting, can be dangerous for your mental health. It is like coming home from a vacation, and going to work an hour later. It also didn't help that at this group's conscience last week, I took a little bit of a beating. Kinda got ganged up on, and got a little bullied. The real truth is AA got bullied and ganged up on that night. Addressing the presence of children at a closed meeting, and reinstating going around the room and introducing themselves, were two of the topics. This meeting is listed as closed, I have trouble understanding how we can tell if everyone in the room has a desire to stop drinking, if we don't introduce ourselves. Also on too many occasions, two or more children are at this meeting, just hanging around. I would not want to be a teacher, or anybody else, walking into this meeting trying to safeguard my anonymity? Well, we had success with the group introductions, but took a loss on the children thing.

Maybe next group conscience we should vote on setting up a play area in the corner? The group also voted NO to asking those in attendance, to try and keep the sharing to topics related to Alcoholism. Another victory for the discussion meeting! Enforce something like that, and what would some people have to share about? I know three or four people at that meeting that couldn't raise their hands then. They also just happen to be

the same ones who share every meeting, and share from five to ten minutes each. Sound familiar to anyone? Recently I attended that meeting, and the same couple of people were doing their close to ten-minute thing. A like-minded friend leaned over to me and said, "don't forget

It must be hard to share about the solution, when you avoid Big Book and Step Meetings like the plague. Or maybe instead of getting the plague, they are afraid of getting some other AA illness. Maybe catching the AA bug is their big concern. You don't want that bug, it has been known to really interfere with life, especially TV. Some symptoms of this bug include, picking up multiple chairs, greeting newcomers, making very strong coffee, and setting up AA literature. Other symptoms include, sharing on topic, and in some very rare cases, greeting people at the door. Some sufferers have been known to get hurt diving head-first into the Big Book. In the most severe cases, people find themselves traveling down to Somerset, N.J. once a year, to attend an AA Convention. This is one really scary bug. Who would ever want to suffer from that? Not me, I think I will just stay in my cozy AA comfort zone, surrounded by all the AA things that I have fear of doing. Or maybe I will venture out, and take that new commitment opening up at the Sunday night Discussion meeting. Activities director/babysitter for all the children at the meeting!

Thank you everyone for your hard work at this years Convention. You did a wonderful job, and your work is so gratefully appreciated. Attending the Convention every year, just proves to me over and over again, that AA works, and who makes it work. I am so grateful to be surrounded by so many like-minded people.

# So Many Times

o many times I tried to stop drinking only to find that my alcoholism was growing. It was growing from the very first drink until I finally stopped. It took many years for me to completely stop drinking. Periodically at times stopping for a week. a month, even a year, but alcohol was imbedded in my brain and I would start again. I did it all to stop drinking, changing brands, from scotch to bourbon, to beer, to just using small glasses, etc. No matter what I tried the drinking went on and on. Passing out then waking up to drink some more. Vomiting it all out and hoping that the next day would be a better day. I just couldn't put my finger on what was wrong with me. I thought that maybe I was just meant to live the miserable life I was living. Each day was worse than the last drifting away from family, friends, coworkers and becoming the loneliest man in the world. At least that's what I felt like.

Then one morning something happened. With the help of the God of my understanding I admitted I had become an alcoholic. I had the disease of Alcoholism. I had tried for so many years to beat alcohol and I now knew it couldn't be beat. I had to stop it with abstinence and changing my life. I realized that from that moment on the compulsion to drink was gone. I no longer had the desire to drink; instead I had the desire to live one day at a time without alcohol. Since that morning my life has changed for the better. I have been sober for over twelve years now and I have the life I was looking for. I no longer try to solve my problems with alcohol. I go to meetings almost every day, sometimes two. I pray every day and I ask the God of my understanding for help in living my life. I no longer try to beat alcohol and be miserable, I now accept the fact that I am an alcoholic and I am happy and grateful.
